#### **PROJECT DESCRIPTION**

Funding is requested to continue the Minor Capital Improvement and Equipment (MCI) program. The MCI projects are required to maintain facilities in good condition, meet life safety and security standards, maintain operational efficiencies and provide appropriate conservation treatments to historic properties and museums under the Division of Historical and Cultural Affairs' stewardship.

#### Proposed projects include:

- Roof inspections, roof/gutter preservation treatments and exterior finishes at campuses and sites statewide;
- Pathway and masonry stabilization continue phased stabilization of pedestrian sidewalks at properties such as Fort Christina and the New Castle Green, as well as brick wall stabilization at Fort Christina:
- Buena Vista Campus development of plans and specifications for scheduled projects identified in the Buena Vista Master Plan;
- Old Brick Church evaluation and development of specifications for exterior envelop conservation and heating, ventilation and air conditioning (HVAC) system improvements;
- HVAC system improvements to multiple sites (Belmont Hall, Zwaanendael Museum, Arsenal and Johnson Victrola Museum);
- New Castle Campus repairs at the courthouse and replacement of the academy roof;
- Cooch-Dayett Mill Campus painting of the barn roof, stabilization of the generator building, demolition of deteriorated outbuildings and structural stabilization of the Dayett House;
- Woodburn/Hall House Campus masonry pointing on security building and Woodburn porch;
- Fenwick Island Lighthouse repair of the roof, replacement of gallery railings and coating of exterior surfaces;
