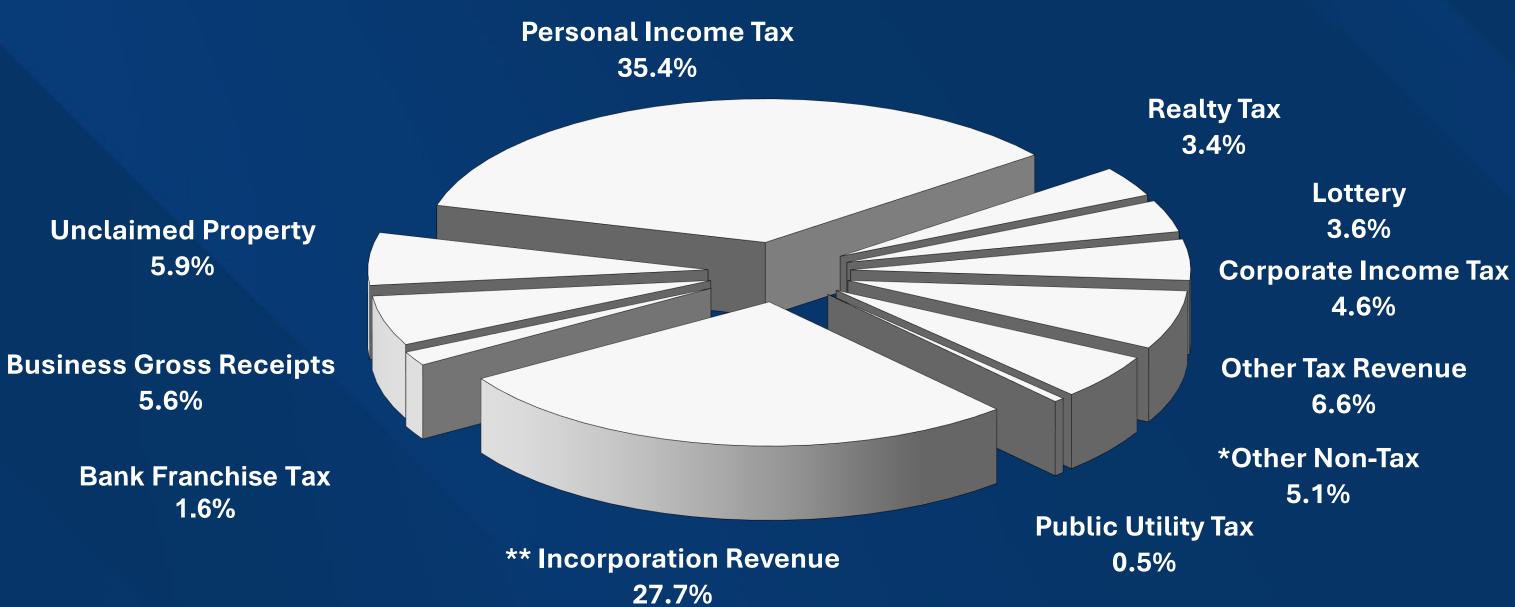

FY 2026 SOURCES OF FUNDS (Net of Refunds)

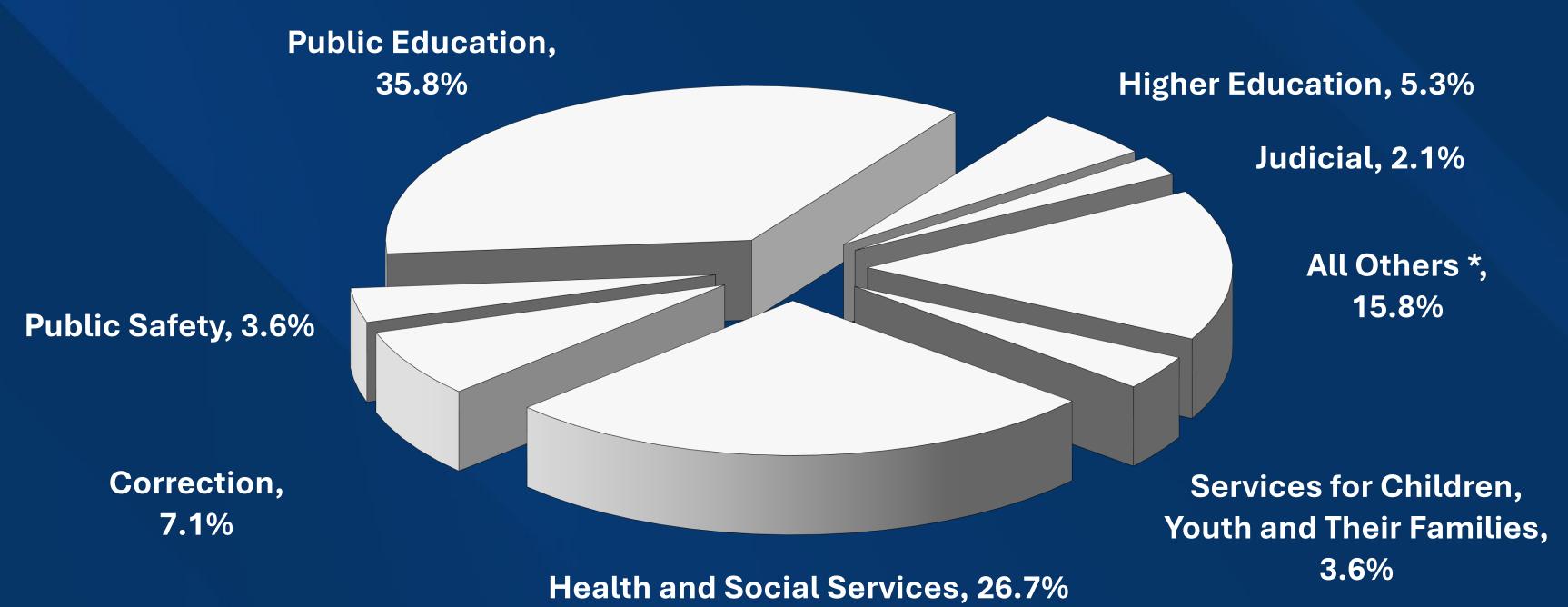

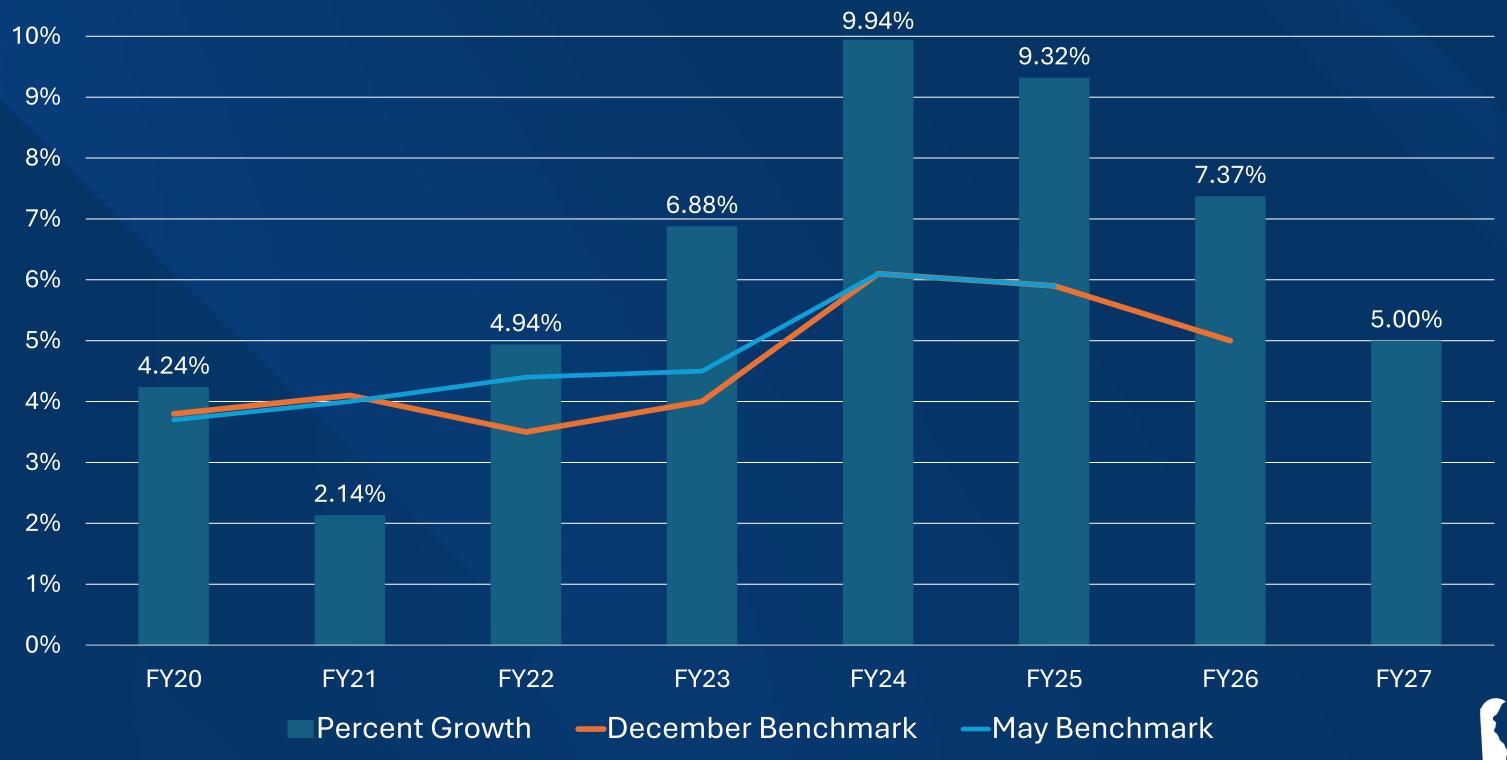
FY 2026 RESET OPERATING APPROPRIATIONS

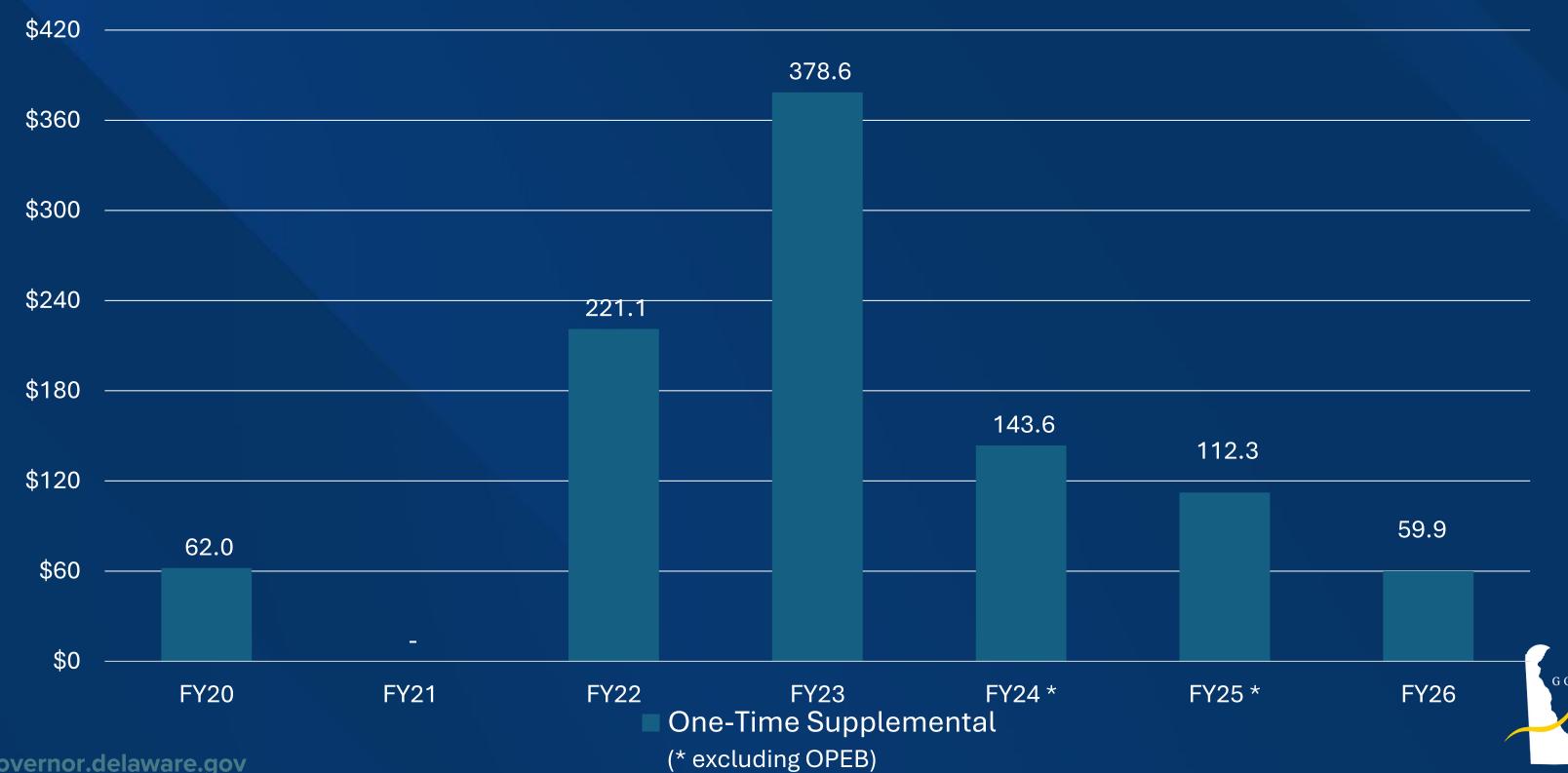
OPERATING BUDGET GROWTH VS. BENCHMARK INDEX

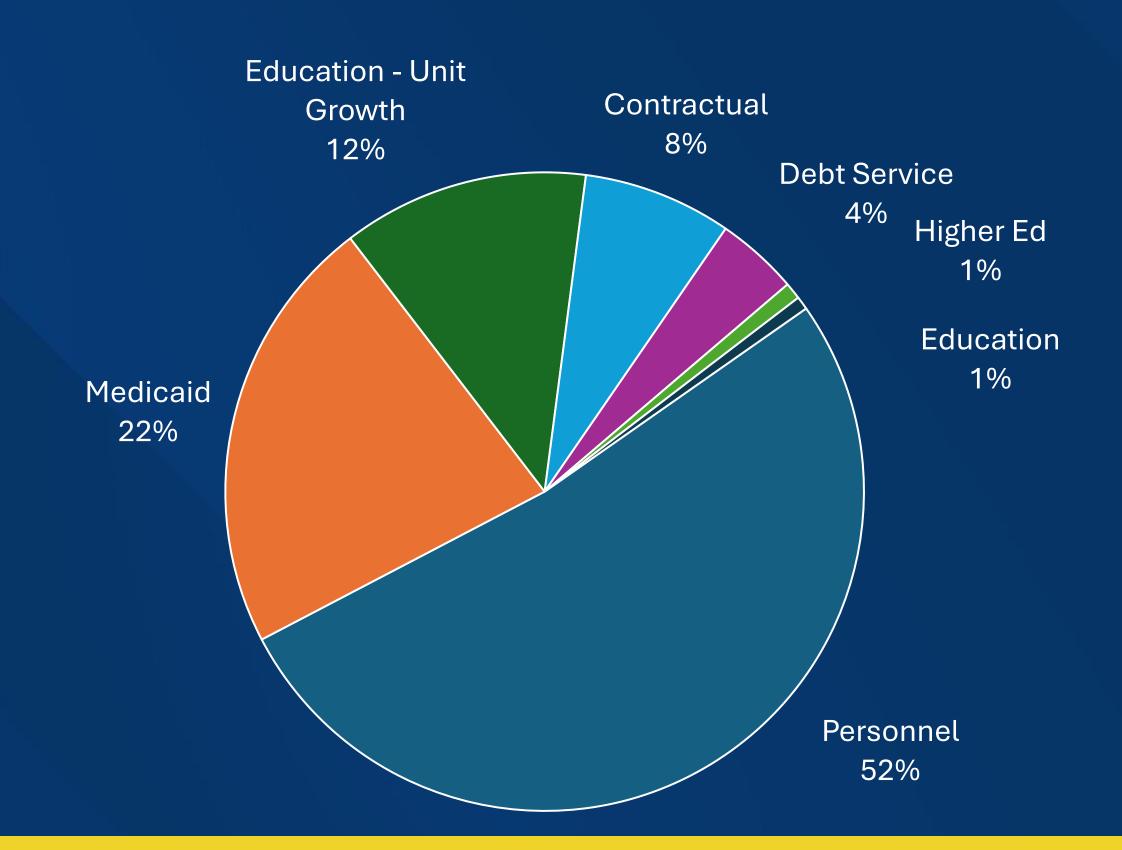

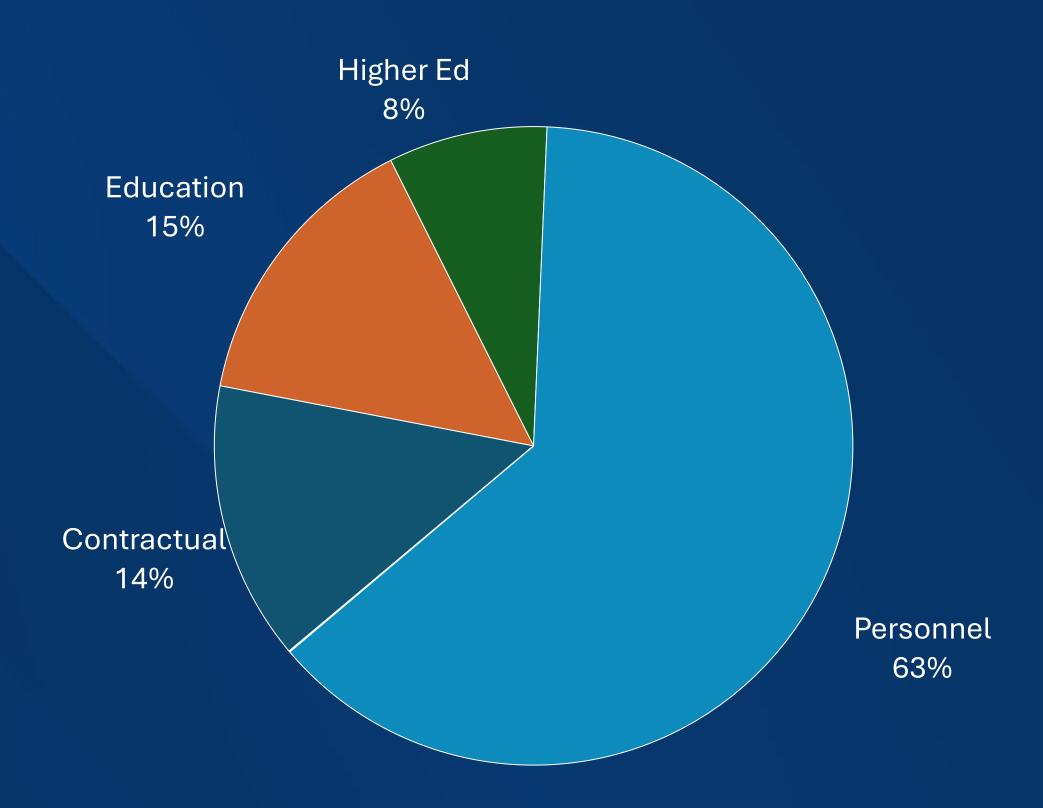
